# 3. COMPETITION DATES

## 3.1. Season 5 Open Time-Limited Events

**Open Qualifiers TLE’s:** June 10, 2024 to June 23, 2024

## 3.2. Season 5 Open Finals

**Open Final:** July 03, 2024

# 4. FORMAT

Players can compete in the series using the Mobile event in-game. Players are allowed to play on either Android or iOS devices to try and qualify for the Finals. The season breaks down as follows:

**Open Qualifier:** Over 2 weeks, players will be able to compete in Time-Limited Events (TLE) in-game. Each TLE qualifies the TOP 2 eligible players.

**Finals:** The TOP 4 players qualified from the Open Qualifier will compete in a Double-elimination bracket. Matches will be played in a Best-of-3 format except for the Grand Final which will be Best-of-5. There will

be no bracket reset. The player coming from the upper bracket will receive 1 track advantage. (Series starts from 1-0)

## 5. PRIZE POOL DISTRIBUTION

All prize money will be paid out within 60 days of the finals occurring. Emails regarding prize payout will be sent out at that time.

### 5.1. Open Finals

\*All Prizes are listed in USD and subject to currency exchange rates.

### 5.2. Prize deductions due to penalty points

Every penalty point that a participant acquires during an event or its qualifiers is penalized with a prize money deduction. The deductions are as follows:

- For every minor penalty point, a 1% overall prize money deduction will occur.
- For every major penalty point, a 10% overall prize money deduction will occur.

The deduction is calculated out of the total prize money awarded to the participant at the end of the last part of the competition in question, including both online and offline won prizes, but excluding the part that is meant to compensate for travel expenses (if any). The deducted prize money will be proportionally added to the other players; thus, no prize money gets lost through penalty points.

It should be noted that a player that received extremely high prize money deductions in total over several of the tournament stages may be disqualified.

### **5.3. Prize deductions due to monetary fines**

Monetary fines are not redistributed to the other participants but just removed from the winnings of the player in question.

### **5.4. Withdrawal of prize money**

As long as the prize money for the ESL has not been paid out, ESL reserves the right to cancel any pending payment if any evidence of fraud or foul play has been discovered.

In case of a disqualification, the player automatically forfeits the prize money won in the phase. Depending on the seriousness of the case, it might be extended to the full amount won during the season.

### **5.5. Transfer of prize money**

The prize money will be sent as a bank transfer or over PayPal. Failure to provide sufficient information for the payments to be complete will result in payments not being made. If a participant has not collected their winnings or redeemed the cheque within one year of the initial payment date the prizes are forfeited.
