



Declaration of Consent - - Legal Guardians

I hereby agree that my above-mentioned child may participate in the above-mentioned event and that his/her name will be published together with the results in the rankings or the direct qualification on the websites, social media platforms, other channels of the organizer and its affiliated companies.

4. It is expressly pointed out that there will be a money profit/cash prize if the above-mentioned tournament is won. The legal guardian hereby expressly agrees that the underage participant may receive this money profit in the event of winning the above-mentioned tournament.

5. Prior to the event, the submission of a photo of the participant can be requested, which can also be published for the purposes mentioned under 3. The legal guardian(s) hereby expressly agree(s) that organizer may record the participation of the participant in sound and vision and produce photographs (hereinafter collectively referred to as "recordings") and use photographs provided by the participant in connection with the tournament. The organizer expressly reserves the right to deny admission to the tournament at any time.

The legal guardian(s) hereby expressly agree(s) that the participant hereby grants the organizer the worldwide, perpetual, non-revocable, transferable and sublicensable right to use the recordings in all known and unknown types of use and guarantees that this right is free of any third-party rights. This includes in particular – but is not limited to – the following rights of use: the right to broadcast (e.g. free/-pay-tv, cable, satellite, mobile-tv, IP-TV, Web-TV), the right to publicly access the recordings on

the internet (e.g. right to download, on-demand-right), the right of presentation and cinematic right (e.g. movie theater, exhibitions, trade fairs), the videogram right (e.g. DVD), the right of reproduction and right of distribution (e.g. in any print publications) as well as the right of use for advertising purposes in connection with the tournament. The organizer is permitted to edit, to redesign the recordings, as well as to combine them with other audio/audio-visual productions and to exploit them to the same extent. However, the organizer is not permitted to use the recordings for direct product advertising (above-the-line-advertising) or for merchandising.

6. In the course of the event personal data of the minor will be processed, among other things, for the management and conduction of the event. I have received and taken note of the applicable privacy notice and I agree with its terms. 7. I hereby declare my consent on behalf of the minor that his/her name as well as photographs and recordings of him/her together with the game results within the scope of the rankings or direct qualification are published on the websites, social media platforms and other channels of the organizer as well as its affiliated companies. My consent or the consent on behalf of the minor can be withdrawn at any time via e-mail to privacy@eslgaming.com. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

Insofar as my consent/authorization is required, I acknowledge that personal data of me as a legal guardian will be stored by the organizer for the purpose of proving its compliance with the GDPR for as long as such proof of compliance is possibly required (legal basis: Art. 6 para. 1 let. c in connection with Art. 8 para. 1 GDPR). This storage period is determined by criteria such as the duration of the exploitation of potential recordings by the organizer. Recipients of the processed personal data are the respective employees and freelancers of the organizer who are responsible for the processing. The company Google LLC (USA) processes the data on behalf of the organizer for the above-mentioned purpose and a corresponding data processing agreement including standard contract clauses to ensure an adequate level of data protection has been concluded for this purpose.
